My comments:

As the consultation document highlights, concessionary bus travel has been associated with reducing loneliness and the degree of social exclusion amongst older people; improving mental and physical well-being, and encouraging a modal shift from car to public transport. For those older people with few family or friends, concessionary bus travel is immensely important with regards to encouraging healthy, active lifestyles amongst older people who suffer from mental and physical disabilities. Concessionary bus travel ensures that older people are able to access vital health and social care services.

The changes that occurred to the state pension age of women have already meant that some women are likely to lose out financially, many of whom have worked in precarious, low-skilled work over their working lifetime, who had planned to retire at 60

years old, and who are now struggling to re-enter the job market. Consequently, removing this right to concessionary bus travel at the age of 60 without gradual, incremental change will negatively impact the financial situation of women who are close to approaching 60, and who had not anticipated the change in legislation on the age of eligibility for a state pension.

The decision to provide companion cards for disabled children under five would reduce the financial costs placed on their carer. It would ensure that the financial concerns of carers do not place a restriction upon a child's capacity to travel. As companion cards are currently available for disabled children over 5 years old, this would ensure that children do not have their access to public services restricted on account of their protected characteristics.

My comments:

Given the clear individual and societal benefits of concessionary bus travel for older people, we do not agree with any policy that seeks to place the financial burden of bus travel upon individual older people. We believe that the Scottish Government should work towards ensuring free bus travel for all older people, without placing restriction upon the time or frequency of travel. This is crucial to ensure that the mental and physical well-being of older people is supported, to reduce levels of social isolation amongst older people, and more broadly, to tackle inequality, so that older people who are struggling financially are not forced to bear the cost of bus travel. Free bus travel is vital to ensure that older people access health and social care services, and in enabling older people to be independent.

The Scottish Independent Advocacy Alliance also believes that the benefits that concessionary bus travel provides to older people would similarly benefit other groups, such as unemployed workers. The Scottish Government should consider how the financial burden placed upon unemployed workers can be reduced, and how their mental and physical well-being can be improved.
