### Introduction

In 2004 the Advocacy Safeguards Agency published *A Map of Independent Advocacy Across Scotland edition 2003–2004*. In 2009 the SIAA published an update to that report, *A map of advocacy across Scotland, 2007–2008 edition*. This new report updates the 2007/08 edition showing the spend on advocacy in the 2009–2010 year and giving a picture of the number of people accessing advocacy during that period.

Based on feedback on the previous document, for this new edition, information on advocacy funding was sought from all NHS Boards and all Local Authorities in Scotland. Information was also gathered from advocacy organisations on income and on statistics collected. Most of the information requested from organisations is already gathered for their own monitoring and reporting to funders.

Responses were received from all NHS Boards and Local Authorities, the majority of advocacy organisations returned completed questionnaires. For those advocacy organisations that did not return fully completed questionnaires, statutory funding information was already available from the commissioners.

The criterion for inclusion in this document is that the organisations only deliver advocacy. All the organisations included in the map have told us that they do provide advocacy although not all organisations are independent.

An independent advocacy organisation is a separate organisation in its own right. For example, they are registered as a charity or company and have their own constitution and their own Management Committee or Board of Directors. Everyone involved in the organisation recognises that they are separate and different from other organisations and services. A fuller definition of independence as it relates to advocacy organisations can be found in the Glossary of both the SIAA *Principles and Standards for Independent Advocacy* and in the related *Code of Practice*.

The SIAA recognises that there are a number of organisations that manage separate advocacy services in addition to providing other services and that this is a pragmatic way of increasing the advocacy available to the people who need it most. However the SIAA encourages NHS Boards and Local Authorities to support organisations to move towards independence.

Data from non-independent and independent organisations is included in this report and the independent/non-independent status is included for all organisations' entries.

Some NHS Boards and Local Authorities included spend on other, non-advocacy, services such as family group conferencing, support into employment, counselling,

advice, support and campaigning services. Details of these have not been included in this document.

The report has been divided into NHS Board areas and includes a description of individual advocacy organisations, their level, source and security of funding. Some organisations have more than one entry as they work in more than one health board area. An analysis of the funding data is included at the end of the document.

All data is included as it was received from advocacy organisations, NHS Boards and Local Authorities. It was cross checked only when there were clear variations between funding information given by organisations and commissioners. The SIAA cannot guarantee the accuracy of all the information included in the report.

Organisations do not have a consistent approach in gathering statistics. For example, some organisations record only numbers of referrals received and advocacy partners seen while others record numbers of contacts. Similarly, for collective advocacy organisations some record only numbers of group members while others record the numbers of attendances at meetings. It should also be noted that the data recorded in the map does not give a comprehensive picture of all activity levels. For example there is no data gathered on the involvement of collective advocacy groups in strategic planning processes. This cannot therefore be assumed to be a comprehensive picture of all advocacy activity nor can it be taken to show a like for like comparison in relation to activity levels.







The total spent on advocacy by NHS Boards, local authorities and the Scottish Government in the 2009–2010 year is £10,122,280. That figure equates to a total statutory spend, per head, per annum, of £1.95.


The total spend, from all sources, statutory and non-statutory, on advocacy from April 2009 to March 2010 was £10,911,028. This equates to a total per person per annum spend of £2.10.

In addition to the direct spend on advocacy Scottish Government funding for the Scottish Independent Advocacy Alliance in the 2009/10 year was £230,000.

## Conclusion


Funding data for this edition of the Map was requested from advocacy organisations and from NHS Board and Local Authority commissioners. We received responses from 95% of advocacy organisations and from all NHS Boards and Local Authorities. Data for the previous edition of the Map came only from advocacy organisations. For that edition, while most advocacy organisations supplied the requested data, there were a few gaps in the final picture.

Although there are gaps in the information for 2007–2008, similar spending patterns in the different NHS Board areas are apparent when comparing the Chart for 2007–2008 with the 2009–2010 version as shown below.

#### Conclusion continued

It is encouraging to note that, other than NHS Fife, for those areas which have some spend on non-independent as well as independent advocacy, the proportion of non-independent advocacy in relation to the total spend has decreased. Some of those non-independent organisations are currently being supported towards independence so we can expect the figures in the next edition of this map to show a further decrease in the proportion of funding for non-independent advocacy.

Some areas show an increase in funding although account should be taken of the gaps in the information supplied for the 2007–2008 Map. Some areas show funding has remained the same for the 2009/10 as for the 2007/08 year, effectively a cut in real terms. Of particular concern is the fact that the NHS Shetland area shows an actual reduction in spend on advocacy of 50 pence per head of population for the 2009/10 year against the 2007/08.

Many advocacy organisations were established following a community development model, set up in response to a recognised need, often by and for local people and rooted in the community which they serve. It is more usual now for NHS Boards and Local Authorities to invite tenders from organisations when gaps in provision are being filled. As a result of this there are increasing examples of large organisations, already providing a range of support and other services, bidding for advocacy tenders in several parts of the country. These do not provide independent advocacy.

Some of the independent advocacy organisations around today were originally established by large, service providing, organisations. Once established these advocacy organisations were supported to become fully independent of the parent organisation. For some of those non-independent organisations contracted in the last few years we are not aware of plans to move to independence. The SIAA hopes that when contracts are awarded to non-independent organisations it is with the understanding that these organisations will then move towards independence within an agreed timeframe.

As before, it is not possible to make direct comparisons between organisations or between different NHS Board areas as this will not be comparing like with like. Different population sizes, advocacy approaches, client groups and differences between rural and urban areas will have an impact on organisations and on the relative spend.


### **Non-Statutory Funding**

The amount of non-statutory funding for advocacy organisations has decreased since the 2007–2008 year.

The total awarded, from charitable trusts and other grant awarding bodies, to advocacy organisations in the 2007/08 year was £955,343, for the 2009/10 year that total reduced to £788,748. This may be due in part to the increasing inclusion of advocacy in legislation.

Despite the decrease in these awards this total shows the significant added value independent advocacy organisations can bring to NHS Board and Local Authority areas.



## Non-advocacy funds

All NHS Boards and Local Authorities were asked for details of their funding for advocacy (independent and non-independent) in the 2009–2010 year. It is concerning that, in response to this request, some NHS Boards and Local Authorities included spend on other, non-advocacy, services such as family group conferencing, support into employment, counselling, advice, support and campaigning services. These are all important services that should be available to those in need of them however this funding should not be recorded as advocacy funding. These totals have not been included in the per person per annum figures for advocacy funding. The total amount of this non-advocacy funding recorded is £919,211.

# Gaps in advocacy provision

Most organisations detailed gaps in advocacy provision in their areas, responses are included in the relevant NHS Board section. Once more there were themes identified in provision nationally.

### Need for development and funding of advocacy in prisons

One issue identified in the last edition of the Map was the lack of access to independent advocacy in prisons. A right of access to independent advocacy, both one to one and collective, under the Mental Health (Care & Treatment) (Scotland) Act 2003 applies to anyone with a Mental Disorder and therefore applies equally to prisoners with Mental Health Problems and/or Learning Disabilities.

It is concerning to note that there has been no change to this situation since the publication of the last edition. In 2011 NHS Boards will take over responsibility for health care for all prisoners from the Scottish Prison Service. Unless additional funding is made available for independent advocacy for prisoners this could have a negative impact on advocacy organisations if they are expected to deliver advocacy to an additional group without any increase in resources.

### Need for development of independent advocacy and equality of access

Other groups for whom there is limited or no advocacy provision include:

- Acquired Brain Injury
- Alcohol related brain damage
- Asylum Seekers and Refugees
- Autistic Spectrum Disorder and Asperger's Syndrome
- Black and Minority Ethnic communities
- Children and young people—particularly in relation to the Mental Health (Care and Treatment) (Scotland) Act 2003
- Homeless people
- People with problem drug/alcohol use
- Physical Disabilities
- Sensory Impairment—including deaf and deafened people

Most of these groups were identified in the last edition of the Map. There seems to have been no significant increase in advocacy provision. All members of these groups experiencing Mental Health Problems already have a legal right of access to independent advocacy however it is not universally available.

#### Conclusion continued

As previously identified, for some of these groups, advocacy may be available depending on where they live, for others there remains no specialist advocacy support and sometimes no independent advocacy. Provision of advocacy for carers remains patchy, as does access to collective advocacy. Although there is advocacy for Older People in all NHS Board areas there are often additional referral criteria so that advocacy is available only for Older People in residential care, with Mental Health Problems or with Dementia.

We are aware that, since publication of the last edition, two advocacy organisations working specifically with members of BME communities have lost funding and have closed. We are unclear as to what action is being taken by the NHS Board and Local Authority to meet the needs of this group since the closure of these projects. We are also unaware of plans in any part of Scotland to improve access to independent advocacy for members of BME communities.

### Need to ensure independence for advocacy organisations

The Mental Health (Care & Treatment) (Scotland) Act 2003 places a duty on Health Boards and Local Authorities to secure the availability, for people with a mental disorder, of independent advocacy.

In her foreword to the SIAA document *Independent Advocacy: A Guide for Commissioners* (February 2009), Shona Robison, Minister for Public Health and Sport, states that:

"The Scottish Government is committed to ensuring that there is appropriate provision across Scotland of independent advocacy for people who need it."

This document revises, updates and builds on the guidance on commissioning advocacy contained in *Independent Advocacy: A Guide for Commissioners* (January 2001) and the *Supplement* (June 2001) published by the Scottish Executive. The revisions reflect the new legislation which includes access to independent advocacy and the updated *Principles and Standards for Independent Advocacy* and associated *Code of Practice* published by the Scottish Independent Advocacy Alliance in 2008. The updated document details the importance of independence for advocacy organisations and ideas on how to ensure independence.

As was identified in the last edition, not all organisations currently providing advocacy for those with a mental disorder are independent advocacy organisations despite the statutory duty placed on NHS Boards and Local Authorities. Some NHS Board and Local Authority commissioners are looking to support existing organisations towards independence. Advocacy planning partners and commissioners should all consider the independence of advocacy organisations, ensure that organisations work within the *Principles and Standards for Independent Advocacy* and support organisations to work towards independence where necessary.

### Adult Support and Protection Act

The Adult Support and Protection (Scotland) Act 2007 is designed to protect adults at risk of abuse. The Act places a duty on Council Officers to 'consider the importance of providing advocacy and other services'. Funding has been made available for Local Authorities to support the implementation of the Act.

Advocacy organisations were asked if they had been funded in the 2009/10 year for work relating to the Adult Support and Protection Act. We are concerned to note that, based on the information received it would appear that only 12 out of the 32 Local Authorities provided funding to advocacy organisations for this work in the 2009–2010 year.

### New developments

Over the past two years the SIAA worked with the Stroke Association to support the development of advocacy for those affected by stroke. Three pilot projects have been run in different parts of Scotland.

Advocacy organisations were asked if they had worked with anyone affected by stroke during the 2009/10 year. Over 50% of all organisations responding stated that, in the 2009/2010 year, they had worked with people affected by stroke. For most of these organisations this was not a referral criteria, those individuals were referred through other criteria such as mental ill health, being an older person, etc.

For many people affected by stroke this may the first time they have encountered specialist health and support services. They may not be aware of independent advocacy and, unless they have contact with health or support staff who know about advocacy or a friend or family member has heard about it or had experience of it, they are unlikely to be referred. The findings of the pilot projects are yet to be published but early indications are that access to independent advocacy can make a significant difference to this group.

Advocacy organisations were also asked if they had worked with individuals with problem drug use in the 2009/10 year. Over 50% of those responding said that they had worked with members of this client group. Most organisations reported that

access to independent advocacy for people with problem drug use is only available through some other referral criteria such as Mental Health Problems.

In May 2008 the Scottish Government published The Road to Recovery, the new strategy on tackling problem drug use. The report states that 'The Government will set in train a number of actions to achieve a shared understanding of how to promote and support recovery, including to ...build the capacity of advocacy service...'

The Scottish Government Drug Policy Unit recognised the need for independent advocacy for people with problem drug use and agreed a project with the Scottish Independent Advocacy Alliance to support the above action point.

The report *Available for All?* on the results of this project makes seven key recommendations including that Independent advocacy—individual and collective should be made available across Scotland for individuals with problem drug use. We are encouraged by the support of the Drug Policy Unit for this action point.

While it is encouraging to see further development of independent advocacy in Scotland it is clear that we still have some way to go in the aim of ensuring that independent advocacy is available to all who need it. If expected local and national government cuts go ahead we will be closely observing any impact on spending and availability of advocacy by noting comparisons in future editions of the Advocacy Map.
