Widening the access to quality independent advocacy

SIAA lobbies the Scottish Government, Parliament, Commissioners other and key decision makers to widen access to independent advocacy.

We do this by sharing the difference it makes in realising people's human rights and pointing out the gaps in independent advocacy provision, and gathering evidence. It is made possible by your help!

Membership Fees and Structure



Membership invoices are normally issued once a year, and should be paid before the end of each financial year.

Context

In 2023, SIAA introduced a new tiered membership fee structure based on the annual turnover of our members.

The aim was to make SIAA more accessible to smaller organisations, while allowing us to grow and develop as a sustainably funded, independent organisation.

It will also further ensure that SIAA can continue to respond to the membership needs.

Membership Tiers and Annual Fees

Tiers	Member's annual income	Fee
Tier 1	<£50,000	£0
Tier 2	£50,001 - £100,000	£104
Tier 3	£100,001 - £300,000	£156
Tier 4	£300,001 +	£208
