The year in review

SIAA underwent significant growth and change in 2022/23, appointing a new CEO and expanding the Board to increase representation and diversity. They developed a fresh strategic plan, taking into account member feedback, to foster connections and promote high-quality independent advocacy in Scotland. There has also been significant development in key policy and legislation that has the potential to impact independent advocacy.

Members currently report at a local level, there is no uniform method of demonstrating the value and overall impact of their work across Scotland. To address this issue, members have collaborated to develop an outcomes framework that highlights their collective impact. SIAA and members have taken hold of opportunities to influence policy and legislation about the potential development of independent advocacy.

Summer Highlight

SIAA and members responded to the two Mental Health Law Review consultations. The Board also developed their new strategic plan based on members feedback and potential policy developments.

Winter Highlight

A working group with members started developing an outcomes framework with facilitation from The Lasting Difference. The group had broad representation from across the membership.

Autumn Highlight

The SIAA successfully held its first inperson conference and AGM during COVID-19, attended by many members and new Board members. Members cooperated on the outcomes framework during the event.

Spring Highlight

SIAA started working on the Advocacy Map to understand the impact of independent advocacy across Scotland. SIAA started to work closely with the National Care Service and prepare for the Human Rights Bill consultation.
