

# **Keynote speaker: Minister for Social Care, Mental Wellbeing & Sport, Maree Todd MSP**

SIAA and attendees welcomed Minister for Social Care, Mental Wellbeing & Sport, Maree Todd MSP as our keynote speaker. SIAA were grateful for the Minister's clear insights on independent advocacy (IA), particularly:

- consistent emphasis on 'independent' advocacy;
- the value of various models of IA e.g. citizen, collective;
- supporting effective IA through an asset-based approach;
- strengthening IA organisations that are thriving at the local level;
- leveraging existing IA expertise when planning future provision.

SIAA and members look forward to working with the Minister and civil servants to ensure IA provision for upcoming policy and legislation is strengthened through the expertise of the SIAA members and see the asset-based approach come to life. ### Speaker: Professor Alan Miller on the National Mission on Drugs: National Collaborative

It was an honour to welcome Professor Alan Miller as our afternoon speaker, where he described the journey of the National Collaborative in strengthening human rights for people affected by alcohol and substance use. Independent advocacy was noted as important in supporting people and families to understand and access their rights and to hold others to account where this does not happen.

Key developments were highlighted such as the launch of the Charter of Rights in December 2024 and the accompanying human rights toolkit. This will further strengthen peoples rights alongside the MAT Standards.

SIAA and members are keen to work with the National Collaborative in making rights real and ensure that people and families can realise their everyday human rights.

### What were we aiming for? And did we achieve it?


### **Conference aims**

- Create opportunities for members to build relationships and have a sense of togetherness
- Provide learning opportunities for stakeholders on capacity and quality
- Support conversations about funding and sustainable independent advocacy
- Provide space to talk about the future of independent advocacy



### Ways we made the conference accessible

- Encouraged attendees to take breaks as needed
- Offered a variety of ways to input and give feedback (on sticky notes, through an online form, verbally)
- Liaised with the venue staff to ensure accessibility requirements were met
- Utilised a presentation, which:
  - was sent to participants ahead of the event
  - was a visual aid helping to navigate throughout the day
  - could be downloaded and followed on own device



### "What would make today a success?"

At the start of the conference, we asked about your expectations for the day. Based on your 78 answers, a successful conference would:

- include opportunities for networking;
- facilitate learning, including learning from peers;
- be a space for discussions and debates;
- result in a shared understanding of an issue or future direction;
- result in feeling empowered, valued, and accomplished.



We recieved 24 pieces of feedback about the conference. That is about a quarter of attendees. Feedback included:

- Attendees agreed attending the conference increased their knowledge and connections, they heard new ideas and shared their own experiences.
- Overall attendees gave the conference 4.5 out of 5 stars.
- Attendees told us they loved the graphic facilitation, they found workshops thought-provoking and gave us feedback about what we could do better next time... more on that below!

- Provide a dedicated quiet space



### What did we learn? Conference workshops

### **Fair Funding - SCVO**



### What did we learn? Conference workshops

# What do we mean when we say "Quality Independent Advocacy"?

This workshop, facilitated by our Engagement and Quality Officer, Marta Wittek, involved 21 attendees <u>brainstorming 52 questions</u> about the following statement:

"We need to make sure that provision of Independent Advocacy in Scotland is of high quality."

The participant group was diverse and included advocacy managers and workers, Advocacy Partners, civil servants, commissioners and advocacy education specialists.

The goal was to uncover the group's collective understanding of quality, drawing from participants' individual perspectives. After coming up with the questions, the group tested out a few approaches to sorting the questions:

- **Thematically** (Whose experience of quality do they relate to?)
- **Prioritising** (Is it possible to prioritise some of the questions?)
- By stakeholder (Who should be asked? Who has the answers?)

Early conclusions were that quality independent advocacy exists in a complex system and that collaboration across the sector is necessary!

Group's work resulted in a collection of considerations for regulating, measuring, and evidencing the quality of independent advocacy. Those considerations, together with key takeaways from the Conversation Cafe, were later analysed to uncover the collective meaning of quality. Results will be used by SIAA to inform the next stages of the project.



### **Skills in Quality Independent Advocacy**

Liisa Lehtinen, our Learning and Development Officer, led this workshop aiming to identify the vital skills and knowledge needed for providing quality independent advocacy. The workshop involved group conversation and reflection. Groups discussed an independent advocacy case study, then outlined the steps they would take to support the advocacy partner.

This collaborative discussion helped identify the practical actions necessary for effective advocacy. Based on the identified steps, each participant pinpointed the specific skills and/or knowledge required to execute those actions. Once these skills and knowledge were collated together, participants reflected as a group on any additional skills and knowledge not previously mentioned.

#### **Workshop results**

- List of skills and knowledge essential for independent advocacy, providing a building block for developing an independent advocacy skills and knowledge framework.
- Participants self-assessment and reflection helped them to identify and celebrate their own skills and knowledge. Many participants expressed increased confidence in their independent advocacy skills as a result.

Really enjoyed the engagement, collaboration and support offered in workshops.

### **Future of independent advocacy workshop**

We were lucky enough to have a workshop on the future of independent advocacy captured by Claire, expert graphic facilitator (see next page for the results!). Huge thanks to Joette Thomas from Animate Consulting for facilitating this thought-provoking workshop.
